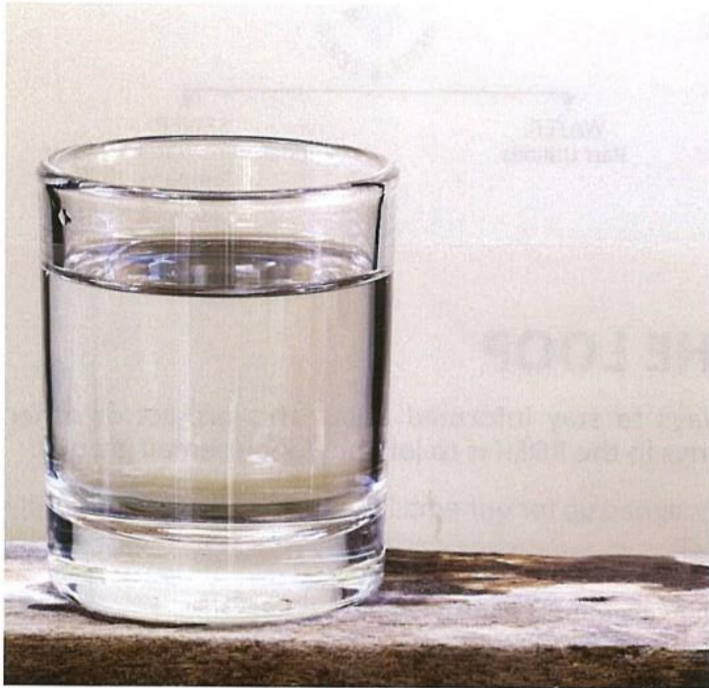

## HOW MIGHT THE RDEK BECOME INVOLVED WITH YOUR WATER?

You may have heard that the RDEK Board directed staff to investigate the purchase of Parr Utilities (currently operated by Windermere Water and Sewer Company (WWSC)) to provide treated water for the Windermere Community Water System Service Area, which has been on a Water Quality Notice since 2006. Part of that process includes assessing the potential impact to both the Windermere and existing Parr/WWSC customers.

It is important to us at the RDEK that we engage you as an existing Parr/WWSC customer and keep you informed as we move through this process. This newsletter is the first step in reaching out to you to provide an update on where we are at and how you can stay informed every step of the way.

## WHERE IS THE RDEK AT IN THE PROCESS?

We are still in the early stages of this detailed, complicated process. We have identified five key milestones to guide us through the process. How this may impact existing Parr/WWSC customers is currently unknown as we are still so early in the process; however, we want to let you know what the milestones are and make you aware that we will share that information when we know more.

### THE 5 PROJECT MILESTONES

#### DUE DILIGENCE



##### Evaluating Parr assets and purchase price

- BDO is preparing a financial review of the Parr Utility system
- RDEK staff are working on business cases relating to the purchase or lease of the building housing the water treatment plant and whether to maintain filter backwash discharge to Windermere Water & Sewer Company or construct an RDEK owned backwash facility



#### SERVICE BOUNDARY



##### Assessment of service area configuration options

- RDEK staff have been working with the Province to assess all the options available to best service all customers, including how to bring the existing Parr customers into a new or existing RDEK service area

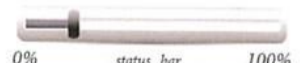


#### FINANCIAL



##### Assessment of financial impact to customers

- Will get underway once the information from the evaluation of costs and service area configurations are better known

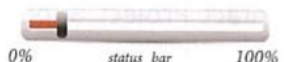


#### COMMUNICATION



##### Keeping You Informed

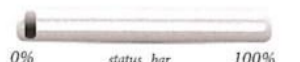


#### ELECTOR ASSENT



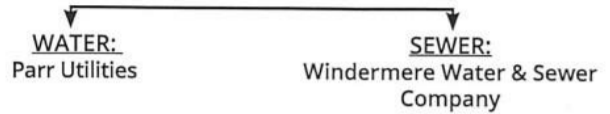
##### Required For Project to Proceed

- The method of assent (petition vs vote) has not yet been decided by the RDEK Board
- Timing of the elector assent process is expected to be Fall 2017 and there will be detailed information provided to the community so all electors can make an informed decision



## WHO'S WHO IN THE WATER ZOO?

In the Columbia Valley, there are a number of different companies who provide water. The two most relevant to the RDEK's potential purchase of Parr Utilities Ltd are the RDEK and Windermere Water and Sewer Company (Parr Utilities is the water branch of WWSC).



**Operates and Maintains:**

- Timber Ridge Water System  
*With purchase of bulk water from Parr Utilities*
- Windermere Community Water System
- Holland Creek (Lakeview Meadows) Water System  
*With purchase of bulk water from Kinbasket Water & Sewer Company*
